BENEFITS

DISCOUNT OR COMMISSION

Choose between the following two options:

*Note: the option chosen will be applied to all events and cannot be interchanged in the same calendar year

OPTION 1: Industry Discount

A 10% discount, based on the rental subtotal, will automatically be noted on every invoice under the "Industry Discount" line.

OPTION 2: Commission Payment

At the end of each quarter, you will be issued a commission payment equal to 10% of the rental subtotal for all closed out orders within the time frame. The invoice will not reflect a commission line and there is no additional charge to the client.

5% LOSS & DAMAGE ALLOWANCE

We understand things happen so to help reduce, or in many cases completely cover those pesky post event fees, you are gifted a 5% Loss & Damage Allowance based on the rental subtotal (free of charge)!

- \$1,000 L&D allowance cap
- Included on all *full price* orders with scullery service
- · Applies to missing & damaged rental items only. Does not apply to labor, overtime and other associated fees

3.5% CONVENIENCE FEE WAIVED

We will waive the 3.5% convenience fee for payments made with credit cards. Therefore there will be no fee for you or your clients to use a CC as a form of payment
